The included notice is to inform you the State Water Resources Control Board (Board) will hold a public hearing on November 5, 2024, to determine if a basin you pump groundwater from, the Kaweah Subbasin, will be designated as a probationary basin under the Sustainable Groundwater Management Act (SGMA).

Why you are receiving this letter: We sent this letter to about 2,934 property owners known to the Board to own (or to have owned) a well and may pump (or are planning to pump) groundwater from the Kaweah Subbasin, based on publicly available well information. Our goal is to inform people who use groundwater about opportunities to provide input related to upcoming decisions.

The Board is considering whether to designate the subbasin as probationary because local agencies do not have an adequate groundwater sustainability plan, as SGMA requires. If the Board designates the subbasin as probationary, it may require some groundwater pumpers in the subbasin to install meters, measure and report all groundwater extractions, and pay fees to cover the cost of Board actions. These Board actions include evaluating basin conditions, assisting local agencies, and potentially taking steps to ensure groundwater is managed sustainably. The Board can choose to exempt people who only pump groundwater for domestic household purposes from reporting and fees.

Please see the included notice and flyer for information on the hearing and two public workshops that will occur prior to the hearing. The notice includes instructions for viewing or participating in the hearing and workshops, as well as background on SGMA and the proposed probationary designation. Please join us at one of the workshops to share your input and learn more.

El aviso incluido es de la audiencia pública que la Junta Estatal del Agua (SWRCB), tendrá el 5 de noviembre de 2024, para decidir si poner a prueba la Subcuenca de Kaweah, de la cual usted bombea agua. La audiencia es según la SGMA (Ley de Gestión Sostenible de Agua Subterránea).

Por qué recibe esta carta: La carta fue como a 2,934 dueños de propiedad que por información pública de pozos, la SWRCB sabe son/fueron dueños de un pozo, y bombean/planean bombear agua subterránea de la Subcuenca de Kaweah. La meta es informar a gente que usa agua subterránea, de oportunidades de dar aporte sobre decisiones próximas,

La SWRCB está considerando si poner a prueba la subcuenca porque agencias locales no tienen un GSP adecuado como lo requiere la SGMA. Un GSP es un plan de sostenibilidad del agua subterránea. Si la SWRCB pone a prueba la subcuenca, puede requerir que extractores de agua de la subcuenca: (1), instalen medidores, (2) midan y reporten toda el agua subterránea que extraen, y (3) que paguen tarifas para cubrir los costos de las acciones de la SWRCB. Las acciones de la SWRCB, incluyen evaluar las condiciones de la cuenca, asistir a las agencias locales, y potencialmente dar pasos para asegurar gestión sostenible del agua subterránea. La SWRCB puede elegir exentar de las tarifas y reportes a personas que solo extraen agua subterránea para usos domésticos del hogar.

Vea el aviso incluido y volante, información de la audiencia y de dos talleres públicos que serán antes de la audiencia. El aviso incluye: (1) instrucciones para ver o participar en la audiencia y talleres, y (2) información general de la SGMA y la propuesta de poner a prueba la subcuenca. The California State Water Resources Control Board (State Water Board or Board) will hold a public hearing at which it will consider designating the Kaweah Subbasin as a probationary basin pursuant to the Sustainable Groundwater Management Act (SGMA). The Board is seeking comments from the public to inform its decision. All members of the public are therefore encouraged to provide input at the hearing, leading up to the hearing at public workshops, or in writing, as described in this notice. The hearing itself will include time for public comments that the Board will consider. Participants can provide comments during the hearing in-person or via Zoom. Spanish interpretation will be available. Additionally, there will be a watch-only webcast option for viewing the hearing. The State Water Board will hold the public hearing at the time and location noted below.

BACKGROUND

SGMA and State Intervention

SGMA (Senate Bill [SB] 1168, Assembly Bill 1739, and SB 1319) requires local groundwater sustainability agencies (GSAs) to develop and implement groundwater sustainability plans (GSPs) so that the many uses of groundwater can continue into the future. If local GSAs do not propose an adequate plan to sustainably manage groundwater use in their basin, SGMA gives the State Water Board authority to protect groundwater resources through a process called "state intervention." State intervention is additional to local management and is intended to be temporary, lasting only until local agencies demonstrate an adequate plan to manage their respective basins.

Inadequate Groundwater Sustainability Plans and State Intervention Trigger

The Department of Water Resources (DWR) has designated the Kaweah Subbasin as a high-priority basin that is subject to critical conditions of overdraft. The GSAs for the Kaweah Subbasin adopted three GSPs for the Subbasin in January 2020 and submitted the plans to DWR for review.

On March 2, 2023, DWR determined the GSPs for the Kaweah Subbasin to be “inadequate.” The DWR inadequate determination of the Kaweah Subbasin GSPs triggers state intervention with the State Water Board. (Wat. Code, § 10735.2, subd. (a)(3).)

Effects of a Probationary Designation

After state intervention is triggered in a groundwater basin, the next step is for the State Water Board to consider making a probationary determination for the basin. This is done through a public process that includes the probationary public hearing discussed in this notice. If the State Water Board designates a basin as probationary, GSAs have time to address the issues (deficiencies) that caused the basin to go into probation while the State Water Board will focus on data collection and analysis to better understand what management challenges are occurring in the basin.

To acquire the necessary data, the State Water Board can require extractors (groundwater pumpers) to install meters to measure and report their groundwater extractions accurately. Alternatively, the State Water Board can specify other means for measuring and reporting groundwater extractions. (Wat. Code, § 10735.2, subd. (c)(3).) Extractors must report all groundwater extractions annually to the State Water Board and pay reporting fees to cover the cost of Board activities, except where excluded by SGMA or the Board. (Wat. Code, § 5202.) The State Water Board may also conduct investigations and gather data necessary for sustainable groundwater management. (Wat. Code, § 10736.6.)

Local agencies have at least one year from the probationary designation to resolve the deficiencies identified by the State Water Board. If they demonstrate to the State Water Board adequate efforts to manage the basin, the State Water Board may end state intervention and extractors would no longer have to report or pay fees to the Board. If, after a year, local agencies have not resolved the deficiencies, the State Water Board may develop an interim plan to manage groundwater use in the basin. An interim plan is intended to be a temporary measure to protect groundwater until effective local management is in place. Adoption of an interim plan would only occur after public notice and a public hearing.
